

- 2) The Document Verification is scheduled on 24.11.2022 at Railway Recruitment Board, Ranchi and the reporting time is 10.00 hrs.
- 3) SMS/email alerts are being sent to candidates' registered mobile/ email ID for downloading their e-call letter from RRB's website.
- 4) Candidates are advised to read the detailed instructions given in the DV e-call letter carefully and bring all the required certificates/documents in original.
- 5) The candidates called for DV should produce all the original documents alongwith two set of photo copies in A4 size paper as detailed in the CEN and e-call letter issued for DV.
- Examination at the nominated Railway Hospitals located in the jurisdiction of concerned RRB on the next day of the DV. The candidates are required to come prepared to stay for three to four days accordingly. Candidates have to pay the prescribed medical fee of Rs.24/- only. Accordingly, candidates have to come prepared for DV and Medical Examination.
- 7) The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter. In case of any inconsistency/deficiency/ discrepancy detected in the information furnished by them in their online application or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.
- 8) It is to be noted that merely shortlisting or calling a candidate for Document Verification/ Medical Examination does not entitle him/her in any way to an appointment in the Railways.
- 9) While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical/ printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.
