<u>List of additional candidates called for Document Verification and Medical Examination for the</u> <u>various post of Level-5</u>

- Further to the notice dated 24.11.2022, a list of candidates provisionally shortlisted for Document Verification and Medical Examination further from the merit list in order to fill the shortfall in empanelment of candidates for the various posts in Pay Level-5 due to absent, rejection, unfit in prescribed Medical Standard etc. is attached as Annexure-I.
- 2. The Document Verification is scheduled from 30.01.2023 to 03.02.2023 with block date as 04.02.2023 at Railway Recruitment Board, Ranchi and the reporting time is 09:30 hrs.
- SMS/email alerts are being sent to candidates' registered mobile/email ID for downloading their ecall letter from RRB's website.
- Candidates are advised to read the detailed instructions given in the DV e-call letter carefully and bring all the required certificates/documents in original.
- The candidates called for DV should produce all the original documents alongwith two set of photo copies in A4 size paper as detailed in the CEN and e-call letter issued for DV.
- 6. Those candidates called for DV may note that after completion of DV, they will be sent for Medical Examination at the nominated Railway Hospitals located in the jurisdiction of concerned RRB on the next day of the DV. The candidates are required to come prepared to stay for three to four days accordingly. Candidates have to pay the prescribed medical fee of Rs. 24/- only. Accordingly, candidates have to come prepared for DV and Medical Examination.
- Candidates are advised to bring Six (6) passport size colour photographs not more than one month old. Candidates will also bring Candidate's foil of e-call letter of CBT 1, CBT 2 & CBTST wherever applicable.
- 8. In case of variation in spelling in name/father's name in the online application and original certificates/documents, on the date of verification, candidates are required to submit relevant affidavit executed before Magistrate or Notary on required stamp papers stating that the referred person in certificate(s) is one & same.
- No additional time will be given to the candidates who fail to produce their original certificates/relevant affidavit on the scheduled date of DV and the candidature of such candidates is liable to be forfeited / cancelled.

- 10. Block date for Document Verification for absentee candidates is 04.02.2023. It must be noted that failure to report for the Document Verification on the scheduled date will tantamount to rejection of candidature unless it is supported by documentary evidence that the candidate had to appear in a University/Government examination or due to sickness of the candidate. No other reason for absence will be considered. No fresh e-call letter will be issued for block date.
- 11. The candidature of all the shortlisted candidates is purely provisionally and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency/deficiency/discrepancy detected in the information furnished by them in their online application or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.
- 12. It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical Examination does not entitle him/her in any way to an appointment in the Railways.
- 13. While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical/printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.
