Schedule for 3rd round of Document Verification and Medical Examination for the posts of Technician Grade-I Signal and Technician Grade-III.

1. The list of candidates shortlisted for 3rd round Document Verification for the post of Technician Grade-I & Technician Grade-III was published in the official website of RRB, Ranchi on 20.08.2025.
2. Further to the above, Candidates with the Roll Numbers given in relevant Annexure for the posts of Technician Grade-I (as Annexure-A) & Technician Grade-III (as Annexure-B) are provisionally shortlisted for Document Verification & Genuineness of Candidature and Medical Examination as schedule below. Candidates are advised to report as per the scheduled date and time mentioned below to the office of Railway Recruitment Board, Railway Offices Complex, Chutia, Ranchi- 834001.
3. SMS/email alerts are being sent to candidates' registered mobile/email ID for downloading their e-call letter from link provided at RRB's website.
4. Candidates are advised to read the detailed instructions given in the DV e-call letter carefully and bring all the required certificates/documents in original.
5. The candidates called for DV should produce all the original documents alongwith two set of photo copies in A4 size paper as detailed in the CEN and e-call letter issued for DV.
6. Those candidates called for DV may note that after completion of DV, they will be sent for Medical Examination at the nominated Railway Hospitals located in the jurisdiction of RRB, Ranchi subsequent to the DV. The candidates are required to come prepared to stay for four to five days accordingly. Candidates have to pay the prescribed medical fee of Rs. 24/- only. Accordingly, candidates have to come prepared for DV and Medical Examination. There are no other charges to be paid to the Hospitals/Health Unit for the medical examination. In rare cases, where the investigation like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital/Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory/Hospital.
7. Candidates are advised to bring Six (6) passport size colour photographs not more than **one month** old. Candidates will also bring Candidate's foil of e-call letter of CBT-1.
8. In case of variation in spelling in name/father's name in the online application and original certificates/documents, on the date of verification, candidates are required to submit relevant affidavit executed before Magistrate or Notary on required stamp papers stating that the referred person in certificate(s) is one & same.

9. Candidates who failed to appear on schedule date must appear on block date given in Annexure. It must be noted that failure to report for the Document Verification on the scheduled date or Block date will tantamount to rejection of candidature and no correspondence in this context will be entertained. No fresh e-call letter will be issued for block date.

10. No additional time will be given to the candidates who fail to produce their original certificates/relevant affidavit on the scheduled date of DV and the candidature of such candidates is liable to be forfeited / cancelled.

11. The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency/deficiency/discrepancy detected in the information furnished by them in their online application or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.

12. It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical Examination does not entitle him/her in any way to an appointment in the Railways.

13. While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical/printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.

Important: Beware of the touts who may misguide the candidates with false promise of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerized and the selection is based on merit of candidates only. Please visit the official website of RRBs for regular updates and information.
